Environmental Management System and Approach

- Comply with the applicable compliance obligation related to the environment.

- Allocate sufficient resources to meet the commitment for this policy.
- Environmental compliance is the responsibility of all employees.
- Drive the environmental compliance management to capture the deviation and potential to deviate for corrective and proactive action respectively.
- Drive for proactive prevention and control of pollution and mitigate its associated risk.
- Considering the entire product life cycle in decision-making, designing a new product to minimize its environmental impact and striving to increase its circularity in the process.

Resources, Energy, Climate change, Green Procurement, Water, Waste and Biodiversity

- Resource: Drive for energy and natural resource conservation by improving awareness and implementing opportunities for improvement.
- Energy, Climate change, Green Procurement:
 - Drive to reduce energy consumption by the maintenance of plant and equipment and using appropriate technologies and driving renewable energy initiatives.
 - Drive for climate change mitigation initiatives.
 - Promote environmentally responsible procurement of goods and services and local suppliers as practicable to reduce carbon footprint.
- Water: Drive to reduce water consumption (fresh water and groundwater), promote rainwater harvesting, and wastewater shall be reduced and recycled as appropriate.
- Waste: Drive for 10 R waste management strategy of circularity to prevent losses for energy, waste, water, and natural resources i. e. design (refuse, rethink, and reduce), consumption (reuse, repair, returbish, re-manufacturing, and repurpose), and return (recycle and recovery) and promote the approach for zero waste to landfill.
- Biodiversity: Protect and enhance bio-diversity values at and around premises, where practicable.

- Drive for thought alignment to build an environmentally conscious company by organizing awareness sessions, leadership talks and promoting reward & recognition for the same.
- Promote and strengthen dialogue, collaborative efforts and consultation with internal and external stakeholders.
